Meeting started at 10:07am Eastern Time with 7 of 12 voting members present.

APMP is seeking a new Treasurer after this meeting (Helene is stepping out after this year).

Baachu Appeal Hearing

- There has been back and forth with Baachu/Baskar about this
- There is a calendar date in November to hear the appeal
- It was determined that the proper iteration of the PEC to hear this appeal (since it is a contractual appeal) is the PEC Chair sitting with the APMP Officers
- Nicole was not a part of the original meeting
- Andy will facilitate a majority of the meeting
- Continuing Baachu promotions
 - Will address this after the appeal, particularly if the revoked status continues
 - ATOs are upset about it, needed to address this to the Board to know that APMP is aware of this.

Board and Vice Chair Election Update

- Putting together the form, it's bouncing back and forth, call for nominations is coming out soon (timeline is not yet firm)
- This year there will be a written application and then a video submission in order to encourage more submission.
- There are 4-6 seats available, Helene is rolling off in December (the Board only took 3 members last year)

Salary Survey

- The 2022-23 salary survey is coming out before Thanksgiving.
- It is a fantastic improvement over past salary surveys with infographics and demographic breakdowns
- We had approximately 2500 respondents to the salary survey

Premium Membership Experience

- We've been working hard on this major strategic initiative
- Revolves around the fact that we have a database that we can work around
- "APMP TV" is a channel that allows our videos to me much more accessible and better
- Salary survey launches by Thanksgiving
- PRIDE Affinity Group will launch by December 7 with two new volunteer leaders it will focus on advocacy instead of activism
- Micro-Certifications
 - Executive Summary and Bid Writing will go live before the end of this year.
 - Another 2 or 3 going out next year.
 - Question re: reasoning for Micro-Certifications

- Some people don't need the entire CP certification (Bid Writer)
- Some people just like to add education and certifications
- Eventually we will have a number of certifications roll up into a Practitioner or Foundations
- Survey going out to members for their top 3 candidates for Micro-Certifications for 2023
- David: Need to update some of the content because hearing that a lot of it doesn't take into account new ways of working (hybrid, etc.). Not saying all of it needs updating immediately, but we need to note which ones.
 - Micro-Certifications and Director certifications are a part of it.
 - Updating the BOK is a priority and will be done, it's 10 years old. It's an ongoing, rolling thing
 - Ahead of Orlando and ahead of BPC Europe, if we can, we will have a BOK update

Treasurer Report

- Every single line item that we can control is better than budget
- Only red we have is investments because of inflation and market. We have been cautious to ensure that we have sufficient resources

2023 Operating Budget

- Events and MarCom have found tremendous success
- Planning a positive, but relatively flat budget for the year
- Corporate memberships and sponsorships have largely been driving growth
- Remain cautious because we are still one pandemic from having to pivot
- Helene's push to add staff has had amazing returns. We will add more staff where appropriate
- Call for questions/discussion
 - No questions or discussion needed (documents and detail were provided in materials)
- Nicole proposes to approve the budget as presented, Coon second
 - Favor 7
 - Opposed 0
 - Abstention 0

Affinity Groups Discussion

- What's working and what isn't working?
- It is one part of APMP's DEI commitment
- Is there one that sticks out is not functioning, we don't need it?
 - Consider moving Veterans and Military to under the NCA Chapter
 - 15 to 20 who participate. They are spread out.
 - Doesn't have the same effect outside of the US
 - Possibly expand to Military/Vets/Public Servants

- The Young Professionals group is extremely active
 - There is a lot of stuff from them, they promote themselves.
 - Most exciting and relevant sessions
- Mental health has been great in its infancy
 - Advocacy is strong
- How is POC doing? Is it engaging as much as the others?
 - POC has less cadence. The ones mentioned as successful have a regular cadence. YP meets monthly to talk and discuss. Mental health will be meeting on a regular basis.
 - o The two that meet quarterly are military vets and POC.
 - POC have recently stepped up and gone to a couple of career days at HBCUs, been active with chapters
- Board members should look to attend more of the affinity groups.
- Link it to the strategy, getting the cross pollination between groups

DEI

- Results of assessment will go out in March with our annual report.
- It starts with the Staff and Board and we want them to look like the membership goals
